JOE O'NEILL:
2019 - 2022 Artists in Schools + Communities Roster - Panel Review
The Artists in Schools + Communities Roster is a resource for schools, organizations and communities to broaden and diversify participation in the arts through the engagement of qualified teaching artists. There are currently 74 teaching artists on the roster. If approved, the proposed roster applicants will join the current roster.

On Tuesday, April 17, 2018, a virtual panel of 4 people was convened to review 27 applicants to the 2019 - 2022 Artists in Schools + Communities Roster. All applicants were previously reviewed by Arts Learning Staff for completeness and eligibility. Applicants applied in either the Education Track or the Community track or both.

All roster applicants were given either a "yes" or "no" vote for each track, by the panelists. All 27 applicants are being submitted for Board approval (see list for applicant names, approved tracks, disciplines and locations).

Marcia Robinson, supervisor at the West Las Vegas Arts Center for the City of Las Vegas Office of Cultural Affairs – North Las Vegas (She holds a M.F.A in Theater from University of California, San Diego and a Doctorate of Education from the University of Nevada Las Vegas.)

GAIL RAPPA:

The NEVADA HERITAGE AWARD honors and recognizes Nevada master folk and traditional artists who, at the highest level of excellence and authenticity, carry forward the folk traditions of their families and communities through practice and teaching. Hazel T Sumile of North Las Vegas nominated Fumiko Duncan, Japanese dancer and dance instructor, for panel consideration. Ms. Duncan is a past recipient of both the Folklife Apprenticeship and Living Traditions grants.

The Grant Review Panel charged with reviewing FY19 Project Grants convened in a public meeting at the Nevada Legislative Building, Carson City, Nevada on May 22, 2018.

PROJECT GRANTS:

- The panelists reviewed and scored 16 Project Grant Applications
- The funding available for this category in FY19 is \$41,375
- The total request for funding was \$95,636
- After panel review and scoring, the total recommended funding is \$69,866
- To honor the thoughtful review and scoring of each application, the panel's recommendation is to apply a 40.8% cut across the board to meet the available funding of \$41,375

*Please note that one applicant for the Project grant received a score below NAC 60% threshold for funding. This threshold was determined by the NAC Board at the April 2013 Board Meeting. The Children's Museum of Northern Nevada received an average score of 35.

GENERAL PROJECT PANEL COMMENTS:

Panelists were a little bit confused regarding the 2 budget forms (one within the application that we had to use with GO Smart and one additional custom budget form that was uploaded to the support material). They also noted that they would have liked to see full organizational budgets for all applicants. In the budget spreadsheet, the panelists would have liked to see more applicants give a full breakdown of artist fees to see exactly how much each artist was getting paid. Although the evaluation forms and narrative questions were helpful, the panelists would have liked to see the results of past

evaluations as well. Over all the panelists provided substantive commentary and constructive suggestions for improvement.

PUBLIC COMMENTS:

There were no public comments in person or via email for the Project Grants panel.

PANEL COMMENTS FOR NAC:

After the panel completed the review process, we asked for their comments regarding the Nevada Arts Council's online grants application system, the review process and any other issue that they chose to share. Here's a sampling:

- The GO SMART system worked fine, but some panelists would have liked to be able to score on the website instead of using paper score sheets
- They felt the orientation webinar and panel binder was very helpful and communicated all necessary information
- Overall, panelists liked having the meeting at the legislature, but some felt it lent an air of formality that may have stifled some more organic conversation about the applications
- Scoring rubric was helpful, but may have been too detailed as it didn't leave much room for interpretation
- In general, panelists enjoyed having a mix of in-state and out-of-state panelists, and said it contributed to objectivity and fairness to have different perspectives

MARK SALINAS:

The Grant Review Panel charged with reviewing FY19 Partners in Excellence Grants convened in a public meeting at the Nevada Legislative Building, Carson City, Nevada on May 22 and May 23, 2018.

PARTNERS IN EXCELLENCE GRANTS:

- The panelists reviewed and scored 44 PIE Tier 1 Grant Applications
- The funding available for this category in FY19 is \$130,870
- The total request for funding was \$302,500
- After panel review and scoring, the total recommended funding is \$239,621
- To honor the thoughtful review and scoring of each application, the panel's recommendation is to apply the following cuts across the board to meet the available funding:
 - o TIER 1 / LEVEL 1 - 37.8% Cut
 - o TIER 1 / LEVEL 2 - 31.7% Cut
 - o TIER 1 / LEVEL 3 - 47.6% Cut

Please note that one applicant for the PIE grant received a score below NAC 60% threshold for funding. This threshold was determined by the NAC Board at the April 2013 Board Meeting. Myron Heaton Chorale Las Vegas received an average score of 48.3.

GENERAL PIE PANEL COMMENTS:

Panelists would have liked to see full profit/loss budget sheets from all applicants. The panelists stated multiple times the importance of evaluations to inform the planning process and program choices for the organizations. As with the Project panelists, the PIE panelists also would have liked to see the results of past evaluations and how that has affected the organizations' strategies. Although many organizations provided high-quality work samples and support material, it was noted several times that the video or audio clips

provided could be of better quality and shown a higher standard of artistic excellence. The panelists also would have liked to see more demographic data regarding the populations that were served by the applicant organizations.

PUBLIC COMMENTS:

There was one public comment for the PIE Grants panel. At the end of the panel, on May 23, 2018, Elinor Bugli, Carson City Symphony and Mile High Jazz Association, thanked the panel for their hard work. Said she knew it was difficult to see such big cuts in the recommended amounts due to the funding restrictions, and said she would continue to advocate for more funds for the arts.

PANEL COMMENTS FOR NAC:

After the panel completed the review process, we asked for their comments regarding the Nevada Arts Council's online grants application system, the review process and any other issue that they chose to share. Here's a sampling:

- Overall GO SMART was easy to use, however the scrolling feature on the application PDF was difficult, suggest using downloaded panel book for viewing on a computer instead.
- Good communication throughout the panel process, maybe include a list for the Lead Panelist of exactly what their lead grant review should include.
- Loved the scoring rubric and the pre/post score section.
- The comments section of the score sheets may have been more effective if it had been broken out into comments on each narrative question with comments on budget, evaluation, demographics and exit surveys especially highlighted.
- At least 50%, if not 75%, of the panelists should be from Nevada. I noticed that the out of state panelists scored harder than Nevada panelists, and so you wouldn't want a lot of outsiders or it will unfairly skew scores.

- The funding available for this category in FY19 is \$38,242
- The total request for funding was \$77,495
- Due to a 13 point discrepancy in the scoring rubric regarding Nevada Academic Content Standards, please see two funding recommendations below which are based on two different scoring scenarios:
 1. Funding Recommendation 1: Using scoring scenario 1, the total recommended funding is \$62,289. A cut of 38.6% would be applied across the board to meet the available funding
 2. Funding Recommendation 2: Using scoring scenario 2, the total recommended funding is \$53,174. A cut of 28.1% would be applied across the board to meet the available funding

*Please note that one applicant for the Arts Learning Project grant received a score below NAC 60% threshold for funding. This threshold was determined by the NAC Board at the April 2013 Board Meeting. Southern Nevada Handweavers and Spinners Guild received an average score of 48.6.

Kathy Griffin, panelist, then responded that there might be a discrepancy between the final scores read aloud and the preliminary scores written on their score sheets due to the conversations that occurred in the panel and the score adjustments.

- The GO SMART system worked for them but they liked the printed application books as well
- Only issue with the scoring was the Nevada Academic Content Standards question for applicants that were not serving students
- They liked the idea of having in-state Nevada panelists as well as regional panelists
- Suggested to let panelists know approximately how long each application takes to review so they can plan ahead for the time commitment

At the end of the panel on May 24, 2018, Tony Manfredi, Nevada Arts Council, noted for the record that staff will be collecting score sheets and reviewing scoring on both grants due to the 87% scoring adjustment.

Kathy Griffin, panelist, then responded that there might be a discrepancy between the final scores read aloud and the preliminary scores written on their score sheets due to the conversations that occurred in the panel and the score adjustments.

PANEL COMMENTS FOR NAC:

After the panel completed the review process, we asked for their comments regarding the Nevada Arts Council's online grants application system, the review process and any other issue that they chose to share. Here's a sampling:

- The GO SMART system worked for them but they liked the printed application books as well
- Only issue with the scoring was the Nevada Academic Content Standards question for applicants that were not serving students
- They liked the idea of having in-state Nevada panelists as well as regional panelists
- Suggested to let panelists know approximately how long each application takes to review so they can plan ahead for the time commitment

EDWARD ESTIPONA:

Recommend to the Board to adopt the funding scenario that was approved for the Arts Learning Project Grants. If no funding scenario was chosen, then

recommend to take the same course of action that was approved for the Arts Learning Project Grants.

SCORING REVIEW:

NAC staff will now facilitate the scoring review based on the approved Funding Recommendations for the for FY19 Arts Learning Component grants. Please see the included Arts Learning Component score spreadsheet. (See Attachment J: Arts Learning Component Score Sheet)

MOTION: TO APPROVE FY19 ARTS LEARNING COMPONENT GRANTS FUNDING SCENARIO 2 RECOMMENDATION: Moved by Edward Estipona; seconded by Mark Salinas. Passed unanimously.

DISCUSSION, REVIEW AND VOTE OF FY19 1ST QUARTER JACKPOT GRANTS PANEL FUNDING RECOMMENDATIONS (FOR POSSIBLE ACTION) (See Attachment K: 1st Quarter Jackpot Score Sheet)

PANEL CHAIR GAIL RAPPA:

FY19 FIRST QUARTER JACKPOT GRANT

The Grant Review Panel charged with reviewing FY19 1st Quarter Jackpot Grants convened in a public meeting via conference call on June 6, 2018 to discuss and score the applications requesting support for projects and activities scheduled to occur between July 1st and September 30th, 2018.

This quarter's panelists were:

- Bobbie Ann Howell, Program Manager, Nevada Humanities - Las Vegas, NV
- Emily Najera, professional visual artist and educator - Grand Rapids, MI
- Tami Castillo Shelton, professional performer, arts educator and arts administrator - Reno, NV
- McKenzi Swinehart, Senior Grants Coordinator, Greater Columbus Arts Council - Columbus, OH

JACKPOT GRANTS - 1ST QUARTER

- The panelists reviewed and scored 14 Jackpot Grant Applications
- The funding available for this category for the 1st Quarter of FY19 is \$10,000
- The total request for funding was \$13,880

- After panel review and scoring, the total recommended funding is \$11,061
- To honor the thoughtful review and scoring of each application, the NAC recommendation is to use the Jackpot funding table included below to meet the available funding of \$10,000

*Please note that one applicant for the Jackpot grant received a score below NAC 60% threshold for funding. This threshold was determined by the NAC Board at the April 2013 Board Meeting. Wolf O'Rourc received an average score of 58.3.

GENERAL JACKPOT PANEL COMMENTS:

- Overall, panelists had a lot of positive comments about the applications including good quality support material, high levels of artistic merit and commendable projects that would promote the arts in Nevada.
- Panelists would like to see clarification on the timeline for projects (does NAC want to see the full timeline for the project or just the portion of the project that fits within the grant quarter dates)
- The Jackpot grant is so broad in scope that the narrative questions don't always line up with the project.
- There were a lot of comments regarding the evaluation process for all projects. Artists need to have clearer methods of evaluation overall.
- Some applicants budgets were not detailed enough, and panelists noted that more detailed budget information would have strengthened those applications.

PUBLIC COMMENTS:

Tony Manfredi, Executive Director, Nevada Arts Council thanked the panel for their work and comments.

SCORING REVIEW:

NAC staff will now facilitate the scoring review for the FY19 Project grants. Please see the included Jackpot score spreadsheet. (See Attachment K: 1st Quarter Jackpot Score Sheet)

TONY MANFREDI:

JACKPOT SCORING PROCEDURES

- During the panel meeting, panelists discuss each application and provide their final score for each applicant.
- Those scores are averaged and that Average Panel Percentage is multiplied by the Grant Request Amount to find the Panel Recommended Amount.
- Then the Jackpot Funding Table (see below) is used to find the Adjusted Amount. The funding percent is multiplied by the initial grant request to find the Adjusted Amount.

- If the Adjusted Amount exceeds the available amount of funding, then funding is determined by awarding the full Adjusted Amount starting with the highest scoring applicants until available funds are depleted. The funding will stop at the last person that is able to be fully funded at Adjusted Amount.
- If there are extra funds at this point, the funds will be distributed to scores from 94% down to 75% by adding Additional Funds to the Adjusted Amount to bring that amount up to the full Panel Recommended Amount. This will continue until all available funds have been allocated.
- The Adjusted Amount (based on Jackpot Funding Table) plus the Additional Funds will equal the Final Recommendation to the board.

We will now review the final scores and recommended funding from the Jackpot scoring spreadsheet. (See Attachment K: 1st Quarter Jackpot Score Sheet)

Arger: Is there any discussion?

O'Neill: This is Joe. Can we go back to that spreadsheet that we were just looking at?

Arger: Yes.

O'Neill: I know that Jackpots are a work in progress, and we're getting there, but I would like to say for this one, one of the issues that I have on this, is it gives an applicant name, it doesn't give the organization, or the region, or District, um city, that they're from. I just think for transparency sake, it would be good if we are listing the organization, and the district or the city, that the award is being presented to.

Arger: Okay, so noted. So that can be basically a housekeeping addition, right, that you're recommending Joe.

O'Neill: Yeah, just a formatting of the spreadsheet. Again, it's just giving a name here, and not the Arts organization that the funding is going to. It's not representing the city in the state that we're funding.

Arger: Right, because sometimes it involves an organization, and sometimes it involves an individual, so giving some added information on location, I think, will be helpful as we promote the Arts around the state, to show where the monies are going around the state. Any other comments?

MOTION: TO APPROVE FY19 1ST QUARTER JACKPOT GRANTS FUNDING RECOMMENDATION: Moved by Gail Rappa; seconded by Ryrie Valdez. Passed unanimously.

PUBLIC COMMENT

No public comment in person or submitted via email.

Manfredi: This is Tony Manfredi, Nevada Arts Council. I just wanted to thank everyone involved with this process in particular. Sierra has done a phenomenal job in organizing the annual grants, Mary Jane with the Arts Learning grants, Pat and Rebecca in regards to the Heritage award. It's gone really smoothly, from my first time going through the process, and I really appreciate staff effort and work in that. In addition. I want to thank all the board members, all of you, for the call today, and all of the all of you who have chaired panels. It's really great to have your leadership and expertise to help guide those, to ask really great questions. All in all it's really helping us improve a process that we're excited about where it's moving. So thank you.

Arger: Thank you.

Rappa: This is Gail. I want to second that Sierra makes our jobs chairing the panels really quite easy and seamless, and I think she does an amazing job, especially just coming in [to this position.] So I wanted to thank her again. Also one thing I was going to note, just kind of an FYI when you're chairing panels, something that I forget to do with our new scoring method. It is on the screen when they're when the panelists are doing their final scoring, but I don't think it hurts to remind them that anything below 60% does not get funded. So, I know it's posted there, but I think it's a good reminder because they do have a chance to change their scoring before it's voted upon.

Arger: I think that's a good point Gail. And because it's there on the screen, it's perfectly appropriate to take a break, before the final vote, and let the panelists just digest their own scores. And give them the opportunity, if they should choose, to make any changes in their scoring before the final vote. I think this allows for transparency. It allows for questions amongst the panelists, and I think it's healthy. So I agree with you Gail. Thank you. Any other comments. I've just a reminder that our next board meeting is on June 28th, and it's in person, and that will be a wonderful opportunity. We're going to get our handbooks, right Tony? And review the handbooks, and just get to be in person, for all of you who are able to come. It will also be streamed in Las Vegas as well. Come prepared to share board members, share what you've been doing for the Arts in your life, at that time. I think that will be a nice opportunity to give your comments on what's going on in your world, amongst the other things that we have on our agenda. So we're looking forward to being together in Carson City on Thursday the 28th. Are there any other comments? Hearing none, we'll move on to agenda item L. I will entertain a motion to adjourn.
